The organization sponsors an annual Music Festival. The two-day event is open to the public and features both amateur and professional bands.

The organization sponsors a Plein Air art exhibition over several days in September. Artists from various States participated and competed for prizes. The public was invited to view and purchase the artists' works.

4c (Code:) (Expenses \$ **131,240** including grants of \$ **0**) (Revenue \$ **269,493**)

Maryland Center for the Art's primary goal is to construct a performing arts center (theater, ampi-theater and related buildings) on 44 acres of land that it owns in Harford County, Md. A significant amount of time expended by Officers, employees and volunteers is devoted to planning the construction and raising the funds needed for construction costs. As of June 30, 2024, those costs are included in the organization's balance sheet. During this fiscal year the organization cleared some wooded land for future construction and installed a parking lot. The organization now uses the property for several events each year.
